



## PARENT OBLIGATION CONTRACT

1. Parents shall attend MANDATORY team meeting with their daughter's team at the beginning of the season.
2. It is the sole responsibility of the parent to provide or arrange transportation for their daughter to and from practices, games, tournaments, and special events. If your daughter walks or rides a bicycle, scooter or other transportation type, a signed note of release MUST be given to your daughter's manager. The manager is already donating a great deal of time, DO NOT keep him/her waiting for you to pick up your daughter from events. Find out when the activity will be over and BE THERE ON TIME. Parents please note: No player shall be allowed to leave practice, games, or other event WITHOUT proper escort (authorized parent/person at least 18 or older). League prohibits picking up your daughter from the parking lot area. Proper escort must walk to the appropriate field or practice area to pick up his/her child.
3. Parent(s) shall notify the manager, coach, or team rep AHEAD of time in the event of illness or injury or other necessary absence from a game, practice or special event (including absences such as Girl Scouts, religious events, etc.)
4. If Parent(s) choose not to exercise their Snack Bar Buyout, they MUST accept responsibility to work the Snack Bar and/or Field Maintenance shifts they committed to. Penalty for non-compliance is forfeiture of \$40.00 per shift to reimburse the WGGSL for hiring a replacement worker even if a replacement worker could not be found and a \$25.00 no show. Rained-out shifts will be rescheduled.
5. Parent(s) must provide their daughter with an approved NOCSAE/ASA regulation batters helmet w/ mask and optional chin strap, softball glove, and rubber-cleated shoes (no steel cleats allowed). Jackets or sweatshirts should be brought to all practices and games regardless of weather. Compression shorts/sliders and kneepads are HIGHLY recommended for protection when sliding.
6. It is prohibited by STATE LAW to smoke on school grounds. Failure to comply with state law may result in our losing the use of Enders School facility. Please go outside of the school property (to the parking lot) if you must smoke. No alcohol, tobacco products, or dogs allowed on school property.
7. To comply with school regulations, and for the safety of our children, there is to be NO vehicle traffic beyond the chain link fence. Exception: Parking behind the gates is restricted to umpires, board members, league authorized deliveries and state authorized handicap persons.
8. Parents must provide their daughter with water or other beverage at all practices and games. Parents must also participate with game snack schedule as requested by your Manager or Team Parent.
9. Parents will respect the coach, manager, team volunteers, umpires, board members and players. Disruptive and/or abusive behavior will not be tolerated at any time and may result in the removal from League activities, disciplinary action (suspension from events, etc.) and/or criminal complaint.
10. **Parents MUST accept responsibility to work assigned field maintenance day(s) and bathroom duty, as well as participate in fundraisers, tournaments, or any other special events, as needed.** Failure to perform your assigned duties may result in the benching of your daughter. Teams with frequent (more than one) violations may result in manager suspension. Parents will be required to serve as official scorekeepers where needed.
11. **Parents MUST wear a mask to and from the softball fields and during the scheduled practice times. Parents must supply a mask for their players.**
12. All balances owed to the league or due to Team Manager/Coach/Parent must be satisfied prior to any future sign-ups.
